# **Proceedings**

#### 1. Admin/Financial

- The Council approved the **minutes** of the previous meeting (28th April 2017). Council members asked for titles to be used more consistently in minutes. Ide proposed the minutes and Sebastian seconded them.
- The Secretariat presented the latest Purchases & Transactions Report for 2017. Council members asked the Secretariat to clarify how they deal with, and account for, Professional Services Withholding Tax (PSWT). The Secretariat will prepare an answer for the next Council meeting.
- The Secretariat gave an overview of the **draft Annual Report for 2016**.
  - Seamus and Michael agreed to email the Administrator to confirm that all Council members have fulfilled their obligations under the Ethics in Public Office Acts for 2016.
  - Council members asked the Secretariat to remove the paragraph about ESRI's COSMO (COre Structural MOdel of the Irish economy).
  - Íde undertook to send details of an event she attended in
    Frankfurt, for the Secretariat to include in the Annual Report.
  - The Council approved this draft version of the Annual Report, subject to those changes.
- The Secretariat presented the revised draft Strategic Plan 2017– 2019. The Council approved it for the Secretariat to send to the Department of Finance.

- The Secretariat discussed **recruitment**: they are currently interviewing Research Assistants, and plan to interview for two intern positions in June.
- Since the previous meeting, the Secretariat received one
  Parliamentary Question. It concerned payments to a particular supplier. The Secretariat submitted a nil return.
- The Secretariat had received no FOI requests. Council members noted that DPER might be able to offer training on FOI for public bodies.
- The Secretariat presented the **Risk Register's "Governance and Structure"** section.
  - Council members asked the Secretariat to:
    - remove references to the NTMA;
    - note that the next internal audit will be about Information Governance;
    - change "the Council signs-off on agreed actions to improve output" to "the Council discusses and agrees actions to improve output".
  - Council members noted that new members of the Secretariat and Council might need training on risk management.
  - The Secretariat intend to request tenders for internal audit, after the Audit and Risk Committee's June meeting.
- The Secretariat introduced the "Bring Your Own Device" policy. The Council discussed it, and its security aspects in particular. The Council approved it, subject to some grammatical errors being corrected.
- The Council approved proceeding with the latest draft of the Service Level Agreement with the ESRI, and requesting an invoice for it.
- The Council plan to email the Department of Finance, referring to their Memorandum of Understanding relating to the "Endorsement Function", requesting access to the ESRI's COSMO tool. The Council discussed different ways of accessing COSMO, and aspects such as cost and support.

The Council discussed relevant macroeconomic and fiscal data and key themes relevant to Chapters 2, 3, and 4 of this report.
