- Declarations of interest:

- The Council approved the minutes of the previous meeting 30th August 2019. Michael Tutty proposed and Martina Lawless seconded them.

The Council adopted the handbook which sets out the legislative basis, the roles, functions and organisational structure of the Fiscal Council and articulates the processes, procedures and documentation in place to address the requirements of the 2016 Code of Practice for the Governance of State Bodies.

3. Endorsement Preparations

The Council discussed the draft Budget 2020 forecasts received from the Department of Finance. As part of its decision-making process, it compared the Department's macroeconomic forecasts to the Council's Benchmark projections and other agencies forecasts; it considered the methodology used to produce the forecasts; and it reviewed past forecast errors for evidence of systematic bias.

4. Flash Budget Release Plans

The Council discussed plans for its release of a visual summary of Budget 2020 shortly after the publication of the budget.

The meeting concluded at 4pm on Thursday 26th September and recommenced at 10.00am on Friday 27th September

5. Council Discussion ahead of DoF Presentation

The Council discussed some further aspects of the Department's forecasts.

6. DoF Presentation

The Department presented its forecasts to the Council and responded to questions from the Council.

7. Council Endorsement Discussion

The Council held further discussions related to the forecasts presented by the Department of Finance. The Irish Fiscal Advisory Council endorsed as within the range of appropriate forecasts the set of macroeconomic projections prepared by the Department of Finance for Budget 2020 for the years 2019 and 2020, emphasising, that this endorsement comes at a time of exceptional uncertainty for the Irish economy.

8. Migration Paper

Ainhoa presented a draft working paper based on her research on 'Predicting Migration in Ireland: a Gravity Model Approach'. The paper is currently in the final stages of the peer process and it is anticipated that the final draft should be available for the Council to review at its next meeting.
