## **Proceedings**

#### 1. Admin/Financial

#### • Declarations of interest:

There were no declarations of interest.

• The Council **approved the minutes** of the previous meeting 29<sup>th</sup> October 2019. Martina Lawless proposed and Michael Tutty seconded them.

#### Matters arising

There were no matters arising.

#### Future Council Appointments

Ms Dawn Holland was appointed as a Member of the Irish Fiscal Advisory Council on 22 November 2019 for a four year period effective 1 January 2020.

Seamus Coffey, Chairperson of the Fiscal Council, has advised the Department of Finance and the Council that he has decided not to extend his term when it expires on 31 December 2019.

#### • Council Fees (July-December 2019)

The fees and time buy-outs for July-December 2019, as agreed in letters of appointment (and approvals set by Department of Public Expenditure and Reform), were approved.

#### Strategic Plan 2020-2022

The Council reviewed and agreed the final version of the **Strategic Plan 2020-2022**.

#### Peer Review

E Casey advised that a Request for Support was submitted via DEPER to the **Structural Reform Support Programme** at the European Commission. An informal update is expected by year end.

#### Budget Ceiling

The Fiscal Council's current funding structure, with the budget ceiling currently linked to HICP inflation was discussed. It was agreed that Eddie would attempt to ascertain what options may be open to the Fiscal Council to review its funding structure with the Department.

#### Conference plans

The Council discussed the focus and potential speakers for the next **Fiscal Council Path for the Public Finances Conference** on 28 February 2020, which will be on the climate change and the potential budgetary challenges associated with it. Seamus and Eddie will issue invitations to speakers in the next few weeks.

Eddie provided an update on the **OECD IFI/PBO meeting** which will be taking place in Dublin on 15, 16 & 17 April 2020.

#### • Standing items:

- Purchases and Receipts book The Council reviewed the Purchases and Receipts book for October 2019.
- Management Accounts: The Council reviewed the Q3 (July-September 2019) management accounts.
- o Recruitment Update:

Recruitment of a Research Assistant is in the process of being finalised with the preferred candidate. Seamus, on behalf of the Council, wished Ainhoa well in her next position and thanked her for her contribution to the Fiscal Council Secretariat.

- The Council received five **Parliamentary Question** since the last meeting.
- FOI Update: The Council received no FOI requests since the last meeting.
- An update was provided to the Audit & Risk Committee (A&RC) on the Council's review of the Risk Register and Risk Policy. In preparation for the Council review of the Risk Register in 2020, the A&RC reviewed Section 1: Reputation and Role. No changes were suggested and the Council will review this section at its next meeting.
- Audit & Risk Committee Meetings: Michael Tutty, Chairperson of the A&RC reported on the meeting held on 2 December.
  - Internal Audit. Mazars attended the A&RC meeting to report on the 'High Level Review of Compliance with specific revisions of the Code of Practice for the Governance of State Bodies' audit, conducted in Autumn 2019. Mazars advised that the audit results indicate that substantial assurance can be placed on the adequacy of the Fiscal Council's corporate governance policies and procedures. There were no high-level or medium-level finds and 3 low-level observation findings. The observations recommend an update to the Code of Conduct and Governance handbook, updates to the Risk Policy and a 3 year Board performance external assessment. Michael Tutty advised that on discussion on the recommendation on the External Assessment of the Board's Performance, Mazars indicated

that this three year assessment would be more limited, focusing on the performance of the Board rather than the organisation.

    Fixed Asset Policy & Procedures.
- The Council re-appointed Martina Lawless to the Audit & Risk Committee (A&RC), as her **membership of the A&RC** ceases on 19 January 2020. It was noted that her current term of office as a Member of the Council is until 31 December 2020, but, that she is eligible for re-appointment for a further term.
