# **Proceedings**

# 1. Admin/Financial

# • Audit and Risk Committee Minutes

The A&RC met on 2 September 2022 primarily to facilitate the finalisation of the annual audit process, Dawn gave a summary of the meeting as follows:

- Georgina O'Mahony (Deputy Director of Audit) and Robert Lawlor (Auditor) presented the OCAG interim report on the Fiscal Council 2021 audit to the Audit & Risk Committee (A&RC). Based on this report, the A&RC recommended the audited Financial Statements 2021 for approval subject to no material changes. The Council at its meeting on 6 September 2022 reviewed and agreed the audited financial statements and the Letter of Representation and it was noted that signed copies have been submitted to the OCAG and the C&AG's auditor report is awaited.
- The A&RC reviewed the draft of the 2021 Annual Report and the draft of the Chairperson's Comprehensive Report and recommend both reports to the Council. The Council reviewed and agreed the current drafts and the finalised reports will be circulated on receipt of the C&AG's Auditor Report prior to submission to the Department.
- The A&RC reviewed the **draft 2023 budget** in advance of its consideration by the Council and recommends this to the Council. The Council reviewed, discussed and approved the draft 2023 budget, subject to making an annual provision in respect of the implementation of system enhancements and recommendations arising out of the Cyber Security internal audit.
- The A&RC reviewed Section 4 (Governance and Structure) of the Risk Register and the Council agreed with the recommended updates to both 4.1 and 4.2 in respect of risk owner(s) and proposed mitigating actions.

The next meeting of the A&RC is scheduled for 16 November 2022.

# 4. Department of Finance presents its forecasts

John McCarthy, Chief Economist/Assistant Secretary General and colleague(s) from Department of Finance's Economic and Budget Division joined the meeting and presented its draft Budget 2023 forecasts and responded to questions raised by the Council. The Council thanked the Department of Finance representatives who then left the meeting.

#### 5. Council discussion on endorsement decision.

The Council held further discussions related to the Department of Finance's forecasts in the context of a decision regarding endorsement. In this regard, a draft of the text of the endorsement letter will be circulated for review and final approval.

The Council was satisfied that the final forecasts are within an endorsable range, taking into account the methodologies used and the plausibility of the judgements made. The Council endorsed as within the range of appropriate forecasts the set of macroeconomic projections prepared by the Department of Finance for Budget 2023 covering the years 2022 and 2023

The Council will discuss the endorsement process and assess the macroeconomic projections in its forthcoming FAR.

# 6. Flash Budget Release and FAR plans

The Council discussed plans for its release of a visual summary of Budget 2023 shortly after the publication of the budget.

It is planned to have an outline of the FAR available approximately three weeks after budget day i.e. mid-October with a view to publication in November.
