# • Declarations of interest:

- **Purchases and Receipts book:** The Council reviewed the Purchases and Receipts book for March and April 2023.
- Recruitment Update: Arrangements have been finalised with the two preferred candidates for the Summer Internship Programme 2023 who will commence employment on 12 June for a 12-week period. The Council discussed its pilot Partial PhD Scholarship Programme offering partial financial and supervisory support for research in the area of fiscal policy and plans to launch the recruitment campaign on 12 May.

Kevin will upload a finalised version of the 'GNI\*' working paper for review with a view to finalising for publication with a hybrid seminar launch in late June.
