Proceedings

- 1. Admin/Financial
- Declarations of interest:

There were no declarations of interest.

- The Council approved the minutes of the meeting of the Council held on 9th May 2023. Michael proposed and Dawn seconded them.
- Matters arising

There were no matters arising.

• Council Fees and Time Buy Outs

The Council Member's Fees and Time Buy Outs for the period January to June 2023, as set out in letters of appointment (and approvals set by Department of Public Expenditure and Reform), were reviewed and approved by the Council.

• Leadership

Sebastian Barnes discussed with the Council and Secretariat his decision to step down both as Chairperson and Member of Council effective 30 June 2023.

The Fiscal Council formally defines the role of Vice-Chairperson, in its formal 'Schedule of Matters' and Governance Handbook, as deputising in the event of the Chairperson being absent/unavailable for any length of time. The Council agreed that Michael McMahon, Vice-Chairperson, would fulfil the duties of the Chairperson from 1 July 2023 until a decision is taken by the Minister for Finance about chairing arrangements. The Council also agreed that Adele Bergin would fulfil the duties of Vice-Chairperson during this interim period.

Appointments are made to the Council by the Minister for Finance following an open selection process through the Public Appointments Service (PAS). The Minister also appoints the Chairperson of the Fiscal Council from amongst its Members.

The Council indicated a strong preference for a permanent Chairperson replacement to be selected by advertising the position of Chairperson separately and on an up to half time basis via an open process as per the recommendation of the OECD review (2021).

• Standing items:

 Purchases and Receipts book: The Council reviewed the Purchases and Receipts book for May 2023.

• Recruitment Update:

Cian Henningan and Áine Stokes, who commenced the **Summer Internship Programme** on 12 June 2023, were warmly welcomed.

There was one applicant for the Fiscal Council's pilot collaborative **Partial PhD Scholarship Programme** which was advertised from 12 May to 9 June. The Council reviewed the application and research proposal and agreed that Tiago McCarthy fulfilled the criteria and is to be accepted on the programme to commence from 1 September 2023. The terms include an annual stipend of \in 12,500 and payment of half of the value of annual course fees (to a maximum o \notin 4,000 p.a.) and levies to an eligible Irish higher education institution for each of up to a maximum of four academic years.

- The Council received nine **Parliamentary Questions** since the last meeting.
- **FOI Update**: The Council received no FOI requests since the last meeting.

• Audit and Risk Committee Minutes

The next A&RC meeting is scheduled for 13 July 2023.

- **Management Accounts:** The management accounts for Q2 2023 will be available for review and approval in early July.
- The A&RC will review Section 3 (Financial) of the **Risk Register** at its meeting on 13 July which will subsequently be reviewed by the Council.

3. Summer Work Plans

An update was provided in respect of Summer Work Plans.

Kevin is finalising a working paper 'Demystifying Ireland's national income: a bottom-up analysis of GNI* and productivity' which will be published on 27 June and presented later that day at the Council's hybrid seminar on GNI* and MDD.

Áine and Cian will circulate their presentation on the Summer Internship project developing output for future updates of the Council's Long-term Sustainability Report. In addition, it is planned to publish the 2020 Summer Internship GG Universe project.

Other areas of work include climate change and preparation and planning for the Council's Pre-Budget Statement.
