As part of its decision-making process, it compared the Department's macroeconomic forecasts to the Council's Benchmark projections and other agencies forecasts; it considered the methodology used to produce the forecasts; and it reviewed past forecast errors for evidence of systematic bias.

3. Council Discussion ahead of DoF Presentation

The Council continued its discussions and preparations for the forthcoming endorsement discussion.

4. Department of Finance presents its forecasts

John McCarthy, Chief Economist/Assistant Secretary General and colleagues from Department of Finance's Economic and Budget Division joined the meeting and presented its draft Budget 2024 forecasts and responded to questions raised by the Council. The Council thanked the Department of Finance representatives who then left the meeting.

5. Council discussion on endorsement decision.

The Council held further discussions related to the Department of Finance's forecasts in the context of a decision regarding endorsement. In this regard, the Council drafted text for the endorsement letter which will be circulated for review and final approval.

The Council was satisfied that the final forecasts are within an endorsable range, taking into account the methodologies used and the plausibility of the judgements made. The Council endorsed as within the range of appropriate forecasts the set of macroeconomic projections prepared by the Department of Finance for Budget 2024 covering the years 2023 and 2024

The Council will discuss the endorsement process and assess the macroeconomic projections in its forthcoming FAR.

6. Flash Budget Release and FAR plans

The Council discussed plans for its release of a visual summary of Budget 2024 shortly after the publication of the budget.

The Councill discussed the focus of the Endorsement note which it is planned to release just after the budget.

It is planned to have an outline of the FAR available for the October meeting with a view to publication in early December.
