Proceedings

1. Closed Session

The Council met in closed session regarding HR issues.

2. Admin/Financial

• Declarations of interest:

There were no declarations of interest.

• The Council **approved the minutes** of the meeting of the Council held on 22 and 26 September 2023. Adele proposed and Dawn seconded them.

Matters arising

• OECD Rec's: request for info

The Council discussed the Department's request for additional information relating to the Chairperson role, and re-grading of Principal Officer and Assistant Principal posts.

• Climate Action Mandate

The obligations arising under the Climate Action Mandate include annual reporting of the implementation of the Public Sector Climate Action Mandate and sustainability activities under the headings - energy consumption, air travel emissions, paper usage, energy management, procurement, and buildings & vehicles.

Items for approval

The draft Budget for 2024, as reviewed and recommended by the A&RC, was discussed and approved by the Council.

Standing items:

- Purchases and Receipts book: The Council reviewed the Purchases and Receipts book September 2023.
- Recruitment Update: The Council discussed temporary vacancies and agreed an internal acting up arrangement for a suitability qualified member of the Secretariat temporarily undertaking the role of Chief Economist and Head of Secretariat, to facilitate a staff loan to the OECD for a planned period. In addition, this will also create a temporary vacancy for an economist on the Secretariat which it is planned to fill via a secondment arrangement.
- The next Audit & Risk Committee meeting is scheduled for 15 November 2023.
- Management Accounts: The management accounts for Q3 2023, together with the 2023 budget review, as reviewed and recommended by the A&RC, were reviewed and approved by the Council.
- The A&RC at its meeting on 15 November will review Section 5
 (Systems and Processes) and Section 6 (Relationship with Others)
 of the Risk Register which will then be reviewed by the Council.
- The Council received five **Parliamentary Questions** since the last meeting.
- FOI Update: The Council received no FOI requests since the last meeting.
- Info Security/GDPR: There were no matters to report.
