Proceedings

1. Admin/Financial

- **Declarations of interest:**

There were no declarations of interest

- The Council **approved the minutes** of the meeting of the Council held on 26 September 2025. Michael proposed and Stephen seconded them.

- **Matters arising**

There were no matters arising.

- **Peer Review**

The Council discussed procurement considerations and agreed its approach. It also reviewed and approved the proposed draft Terms of Reference for the forthcoming peer review. Niall will engage further with the OECD establishing more detailed costings and timelines with a view to commencing the process in 2025.

- **Audit and Risk Committee**

Alessandro Giustiniani, Chair A&RC, reported on the A&RC meeting held on 13 October 2025 as follows:-

- Caoimhín Broderick (Audit Manager DNKN Moore), from the firm newly appointed for the provision of internal audit services attended the A&RC. A draft Internal Audit Plan 2026 to 2028, outlining two audit areas per annum, on the recommendation of the A&RC, was reviewed and agreed by the Council.
- Updates to the **Internal Audit Activity Charter**, revised by Moore to align to the requirements of the updated Global IIA standards, was reviewed and is recommended and was reviewed and approved by the Council.
- Reviewed and recommend to the Council the **Management Accounts** for Q3 2025, to include the outturn against the budget, which were reviewed and approved by the Council.
- The A&RC also reviewed the draft 2026 budget.
- The A&RC reviewed, discussed and recommended a number of updates to both Section 5 (Systems and Processes) and Section 6 (Relationship with Others) of the **Risk Register**, which were reviewed and agreed by the Council.
- The A&RC reviewed a number of policies and documents which are recommended to the Council and were agreed and actioned by the Council as follows:

Employee Handbook and HR Manual - the Council reviewed and agreed the proposed updates.

Media Relations Policy - the Council reviewed and agreed the updated policy to include the integration of the Social Media Policy;

Code of Business Conduct - the Council reviewed and agreed the unchanged document;

Business Continuity and Disaster Recovery Plan - the Council reviewed and agreed the unchanged policy.

The next Audit & Risk Committee is scheduled for Monday 9 February 2026 to coincide with year-end (2025) timelines.

The Council reviewed and discussed the Council's proposed draft Budget 2026 and proposed revisions to certain cost centres within the Council's budget 2025. These will be circulated to the A&RC for review and recommendation in advance of the Council's final approval.

The Council discussed potential themes and speakers for its Annual Path for the Public Finances Conference which will be held at the RIA on Thursday 19 February 2026.

6. Upcoming Work

An update was provided on upcoming work to include: the CT working paper and a proposed collaboration with the competitiveness and productivity council. Work is also commencing on exploring the impact of ageing on tax revenue.
